IN CONFORMITY WITH THE JANUARY 1, 2026 ENACTMENT OF CALIFORNIA SENATE BILL 707 (DURAZO) AND LA CITY COUNCIL FILE 23-1114, THE RAMPART VILLAGE NEIGHBORHOOD COUNCIL MEETING WILL BE CONDUCTED VIRTUALLY.

Every person wishing to address the Committee must dial 669.900.6833, and enter 851 6123 2288 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Committee on any agenda item before the Committee takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Committee meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of the Committee.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. **California Government Code Section 54953.8(b(3)).**

The legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. **California Government Code Section 54953.8(b)(4).**

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. **California Government Code Section 54953.8(b)(5).**

A legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to paragraph (5), to provide public comment until that timed public comment period has elapsed. **California Government Code Section 54953.8(b)(6)(A).**

A legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to paragraph (5), or otherwise be recognized for the purpose of providing public comment. **California Government Code Section 54953.8(b)(6)(B).**

On March 5, LADOT provided the [ATP6 Fact Sheet](#). Jack Linares, Community Affairs Deputy, Office of Vice President Dr. Rocio Rivas, Board of Education, District 2, is in the process of setting up parent meetings among the local LAUSD schools and community partners. In an April 15 call with Jack Linares, Board of Education, District 2, Emma Howard and Ted Walker of CD 13, and Philip, Jack said their parents want to know about safety plans and completion of safe zones. In response, Emma said she would check in with LADOT to give us an update and also check in with CD 1.
 - 2. Discussion of initiative of the [Bureau of Street Lighting](#) (BSL). The PPPWLU Committee is also looking to share with the PSHT the lead for this initiative. BSL is currently conducting introductory presentations to share general information about its work and to gather feedback from community members regarding their concerns. They are also looking for opportunities to collaborate on future engagement initiatives. At our April 8 PSHT Committee meeting, Alberto said he understood BSL is looking for opportunities to collaborate because there is a ballot measure.

 - 5. Discussion and possible action regarding the Security Committee. Last month, Alberto notified us of a regular meeting of Rampart Village organizations near the Lafayette Park area. They call it a Security Committee, and they meet on the 4th Thursday of the month at 11am. The next meeting is July 23. They offered to have an RVNC presence at the meeting. Members of this group include HOLA (the main organizers), Larchmont School, Rise Kohyang Elementary School, and others. There is a traffic safety issue in that Benton Way is offset from Lafayette Park Pl., but many drivers - guided by GPS navigation - use Lafayette / Benton as a through street, and cut across 6th St. recklessly. The school that is right there - Rise Kohyang ES/MS

has succeeded slightly in getting a crosswalk installed across Lafayette Park PI. in an attempt to help their students cross safely E/W on the south side of the street, but many drivers do not honor the crosswalk and cut across. The Security Committee would like to see something that either allows for safe N/S car traffic (a stop sign, traffic light, etc.) or something that prevents that from being a legal route.
