- B. **Upon the recommendation of the RVNC President, SUPPORT the motion presented by Councilmembers Bonin, Ryu, and Koretz, and seconded by Harris-Dawson recommending for Council action to:**
 - 1) **INSTRUCT the City Clerk (Clerk) and Department of Neighborhood Empowerment (DONE) to allow NCs to roll-over the entire remaining balance on June 30, 2020 of each NC's funds into Fiscal Year (FY) 2020-2021, without a corresponding reduction to the regular budget allocation of funds to each NC for the FY beginning July 1, 2020.**
 - 2) **DIRECT the DONE to expedite authorizing NCs to meet via teleconference and provide necessary assistance to do so.**
 - 3) **DIRECT the City Clerk to expedite processing of NC grants to local COVID-19 related relief organizations, including, as feasible, in advance of receipt of Neighborhood Purpose Grant applications, during the Local State of Emergency and require that NCs report on the grants made with an explanation, including the relationship to COVID-19 relief.**
