In addition to increasing the number of stations, the Committee noted that a stakeholder requested that the charging stations include theft deterrence to prevent theft of charging cables. At the September 20, 2022, General Board meeting, this list of potential sites was given to Juan Fregoso for CD 13's consideration. Philip also asked LADOT and LADPW for more information on their plans for expanding availability of charging stations.
- K. As recommended by the Public Safety, Housing & Transportation Committee, discussion and possible action on identifying two locations for bike corrals in CD 13, including at the LA Ecovillage Institute's Community Hub at 3554 W. 1st Street, CA 90004 and having the RVNC General Board identify another location. Tam Nguyen of LADOT has informed us that LADOT will maintain the bike corrals and will not require that community partners apply for the program and sign maintenance agreements. At last month's meeting, this item was postponed until today's meeting. GENERAL PUBLIC COMMENT ON NON AGENDA ITEMS

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Board.

AB 361 Updates -

Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.
